Successful mating will be determined by traditional breeding (live cover) or Artificial Insemination. Both parties agree that the dam and stud being bred are up-to-date on vaccines, clear brucellosis tests (unless otherwise waived), and are in good overall health.

Successful breeding is defined as one or more puppies produced. If no puppies are produced a certified, official veterinarian statement is required to secure a re-breed, for guaranteed services, ONLY. The statement must include the date, the date of the breeding, dog's name, breed, and microchip number.

Qualifications for Guaranteed Services

- 1. A negative brucellosis test must be obtained within the 14 days preceding the service.
- 2. Progesterone testing must be performed to determine ovulation and accurate timing for the method of insemination being utilized.
- 3. Proof must be submitted of failure to conceive. This can be a veterinarian's statement and/or x-ray. Stud owner must be notified within 70 days of the breeding of failure to conceive. Proof must contain identifying information, date of exam, date of breeding, microchip information and dog's name. Statement should be e-mailed from the vet's office to valerie@valeurahfarms.com.

If the bitch fails to conceive on the first service and the above criteria has been met, the stud owner will provide a free re-breed with the same stud, or a different stud of the same or lower stud fee. If bitch owner chooses to use the free rebreed with a different boy of higher stud rate, then the difference between fees is owed. The free rebreed can be utilized on the same female, or on a different female at the bitch owner's discretion. Free rebreed must be utilized within 18 months.

There will be NO CASH REFUNDS. If the second breeding also fails to produce a litter and the stud(s) have successfully sired litters in between breedings then this contract will be considered fulfilled. If the stud has not produced a successful litter in the time between breedings then a cash refund will be offered or a third rebreed can be extended utilizing a different stud. Stud owner is not responsible for any veterinarian bills, shipping expenses, and/or other monies spent.

Shipped Fresh Chilled Semen

Shipping fees are the responsibility of the bitch owner. We typically ship via UPS for next day delivery, this charge is approximately \$75 - \$250, depending on your location, day of the week and time of arrival. This will be communicated to you with receipt proof of cost. Payment is due at time of shipment. UPS.com can be utilized to pre-determine the cost of shipment. The dimensions of the box are 12x10x8 and approximate weight is 4 pounds.

The shipped box will contain ONE vial of semen ready for insemination. If you would like TWO vials in the same box, sufficient time must be given to allow for two collections. We DO NOT split collections. We utilize a Long-Term (10 day) extender to ensure maximum efficiency and life. If you would like a second vial, shipped in a different box, you will pay for the additional box (\$19.95), extender (\$48.94) and shipping, you do not owe a second stud fee (unless choosing to use a different stud).

If the semen arrives non-viable a reshipment will be collected and sent ASAP provided proof of non-viability is provided. Proof can be in the form of a statement from the Veterinarian or video evidence of the semen under microscope examination.

There is a \$100 non-refundable scheduling fee, payable at the start of the bitch's heat. This guarantees the availability of the stud and is applied to the full total due.

By signing below, both parties agree and understand the above-stated terms of the contract.

In the event of disputes regarding this contract, all legal action will occur in Spokane County, WA. Bitch owner will be liable for all court costs and legal fees.
